FURNITURE LIMITED WARRANTIES

Aluminum Frames — Are warranted to be free from defects in workmanship and materials for a duration of 5 years.

Steel Frames — Are warranted to be free from defects in workmanship and materials for a duration of 1 year.

Fabrics — Are guaranteed for a duration of 1 year against separation for the seams. 5 years Fading on Subrella fabric only.

Frame Finishes — Paint is guaranteed against blistering, cracking and peeling for a duration of 1 year provided there has been no scratches or abrasions. Chips and scratches resulting from normal wear and tear are not covered by this warranty. Fading resulting from being exposed to the elements is also not covered.

Resin Wicker — Guaranteed for a duration of 1 year against unraveling or tearing.

WHAT IS NOT COVERED

West Coast Casual Inc warrants (to the original purchaser only) that its products are free from defects in materials or workmanship as listed above. This warranty excludes general frame rusting, glass breakage, damage caused by improper assembly, abuse, discoloration or fading of the finish or fabric as a result of being exposed to the elements, accident, misuse, negligence and commercial use, disaster, accident or acts of nature such as wind, fire or freezing weather. Prior to returning any defective product or parts under the warranty for inspection, the original purchaser must obtain a written authorization from West Coast Casual Inc's customer service representative at 1-877-8485811 or by writing to customerservice@westcoastcasualinc.com. Defective products must be shipped prepaid with proof of purchase to the WCC Service Center at 5217 Verdugo Way, Suite F, Camarillo, CA 93012. Collect freight shipments will be refused.

After through inspection and if your product has been verified as defective within the warranty period, West Coast Casual Inc at it's discretion, will repair or replace the product at no additional charge. If the model is no longer available or cannot be repaired effectively, we reserve the right to substitute items of our choice in similar style and quantity. In no event shall West Coast Casual Inc's responsibility exceed the value of the original product.

As some states do not allow exclusions or limitations on an implied warranty, the above exclusions and limitations may not apply. This warranty gives you specific rights and you may also have other rights which vary from state to state.

USE AND CARE INSTRUCTIONS

Never use solvents or bleach on metal frames or cushions. The frame can be treated with a 1-step liquid wax for protection against UV light and damp, salty air. To protect from the elements, cover with outdoor furniture covers or store in a cool dry place. You can clean cushions or mesh with a mild solution of soap and water. Rinse thoroughly and allow to drip dry. Do not machine wash or tumble dry, as this may cause shrinkage. When cleaning table tops, use a clean soft cloth that doesn't fade color.
